And this Accountant is advised & doth insist that by Virtue of the said Articles of Agreement she is well intituled through her life as well to the interest of the said Sum of Two Hundred and Fifty Pounds received by the said Nicholas Crumpler before his marriage with this Accountant as also to the Interest of the said sum of Sixty Six Pounds & Three Shillings received by him after his said Marriage in Right of this Accountant And that from and after her Decease the said several Sums of Two Hundred and fifty Pounds & Sixty Six pounds three Shillings will go and be due payable to such of her Children begotten by the said Nicholas Crumpler as shall be living by Save & Virtue of the said Articles of Agreement.
